September	<ul> <li>Introductory memo is emailed to school administrators outlining the 2024-25 ISPA process and suspension dates</li> <li><i>Registering your child for school?</i> tear-off pads are sent to schools to provide to new student registrants throughout the school year</li> <li>ISPA overview and education is provided to school administrators</li> </ul>
October	<ul> <li>List of students who have no vaccination records on file with Public Health is emailed to school administrators. A letter to parents/guardians will be attached for school administrators to print and distribute to students on the list only</li> <li>Monthly ISPA key messages is emailed to school administrators to share with school community through school website and/or messaging system</li> </ul>
November / December	<ul> <li>Monthly ISPA key messages are emailed to school administrators to share with school community through school website and/or messaging system</li> </ul>
January	<ul> <li>Notification Letters are mailed by Public Health to parents/guardians of students who have incomplete vaccination records</li> <li><i>Did you receive a letter</i>? tear-off pads are sent to schools to provide to parents/guardians who have questions about ISPA</li> <li>Monthly ISPA key messages are emailed to school administrators to share with school community through school website and/or messaging system</li> </ul>
February	<ul> <li>Monthly ISPA key messages are emailed to school administrators to share with school community through school website and/or messaging system</li> </ul>
March	<ul> <li>Suspension Orders are mailed by Public Health to parents/guardians of students who have incomplete vaccination records</li> <li>Copies of Suspension Orders are sent to school administrators (for your records only)</li> <li>List of students who still have incomplete records and have received suspension orders is emailed to school administrators. A <i>suspension reminder slip</i> will be attached for school administrators to print and distribute to students on suspension list only</li> <li>Monthly ISPA key messages are emailed to school administrators to share with school community through school website and/or messaging system</li> </ul>
April	<ul> <li>Updated list of students who still have incomplete records is emailed to School Administrators. A <i>final notice</i> will be attached for school administrators to print and distribute to students on suspension list only</li> <li>Suspension period instructions are emailed to school administrators</li> <li>Monthly ISPA key messages are emailed to school administrators to share with school community through school website and/or messaging system</li> </ul>
Мау	<ul> <li>Suspension period is May 8, 2025 – June 5, 2025</li> <li>List of students who are suspended is emailed to school administrators the evening of May 7, 2025</li> <li>Updated suspension list is emailed to school administrators after 5 p.m. Mon-Fri throughout suspension period or until no students in the school remain suspended</li> <li>Monthly ISPA key messages are emailed to school administrators to share with school community through school website and/or school messaging system</li> </ul>
June	<ul> <li>Any students remaining on suspension list can return to school as of June 6, 2025</li> <li>Wrap up email and feedback survey is emailed to school administrators</li> </ul>
